Influencing Credibility: Opening the Black Box of Trust

In the last decade, major academic publishers like Elsevier and Springer have shifted their business focus from publishing to data analytics services. These research information systems allow scientists to identify relevant publications and data sources, but they may impact the credibility of research as well as the freedom of research. In his talk, René von Schomberg will examine these developments and their consequences using three examples: the steering of research objectives, the profiling of researchers, and the erosion of knowledge commons.

Dialogue between Citizens, Science, and Policy: Rethinking EU Enlargement

In a time of democratic backsliding, shrinking civic space, and geopolitical uncertainty, the question of how to advance EU enlargement has become more urgent than ever. More than 20 years after the Thessaloniki Summit, the enlargement process faces a crisis of credibility: while the EU frames enlargement as a strategic necessity, progress is slow, hindered by bilateral vetoes and "enlargement fatigue," and citizens across Europe often feel excluded from the debate. This panel brings together perspectives to explore how EU enlargement can be "future-proofed." The discussion will examine how science, politics, and civil society can be better connected, and how effective communication can help rebuild trust and engagement with citizens. Drawing on recent surveys, workshop findings, and a comparative analysis of reform proposals from the project "A comparative approach to different models of EU integration: How to achieve a citizen-based, enlarged and reformed EU?" by Charlemagne Prize Fellow Sophia Beiter, the panel will explore strategies for making Europe's enlargement approach more resilient, inclusive, and credible for the future.

Europe in the Tech Tug-of-War: Does EU Tech Law Dilute Europe's Voice?

The panel seeks to examine how Europe can reconcile economic competitiveness, technological sovereignty, and regulatory ambition within an increasingly polarized global tech landscape. The discussion will navigate the fine line between maintaining legitimate regulatory authority and creating fertile ground for innovation and progress — a balance essential for ensuring that Europe remains future-ready, resilient, and capable of shaping the global technological order. At its core, the session asks whether Europe's well-intentioned guardrails risk fragmenting its innovative capacity, or whether they can instead serve as the foundation for a distinctively European model of freedom through responsibility and trust. Bringing together perspectives from research, industry, and policymaking, the panel will offer a rich cross-section of insights into the tensions and synergies that define Europe's pursuit of technological leadership in a transatlantic and global context.

The European Union's mission to create 100 climate-neutral and smart cities by 2030 is ambitious, aiming to drive a sustainable, inclusive, and resilient urban future. But is this target truly achievable? This panel brings together perspectives from policy, civil society, practice, and academia to tackle this pressing question. The discussion will explore the mission's objectives, the role of cities in reaching the EU's 2050 climate neutrality goal, and the mechanisms for monitoring progress. It will also highlight the opportunities and challenges faced by local stakeholders, how collaboration is reshaping urban strategies, and the academic insights into reducing the built environment's climate footprint. Together, the panel will examine innovative approaches to accelerate the path toward climate neutrality, balancing prosperity, sustainability, and heritage, while reflecting on lessons learned to assess whether achieving 100 climate-neutral cities by 2030 is within Europe's reach.
